Query no. 3:

Point 10.1. in the tender documentation

When developing the performance time tables, the applicant shall also consider the fact, that the construction works must be coordinated mutually with construction works performed by town of Uherský Brod.

At the same time, the applicant shall in his construction work time table take into account the terms assumed in the construction work time table performed by town of Uherský brod. As per our information sources, until now haven't been selected any winner of the tender procedure for town of Uherský Brod, and therefore, the construction work time table is not available.

We kindly ask you to amend the tender documentation with following sentence.

The construction work time table submitted together with the bid is to be of informative and indicative nature and the selected applicant shall submit an updated time table within 14 days after receipt of construction work time table

Terminal Uherský Brod- investor town of Uherský Brod.

Answer to query no. 3:

Submitted coordination time table in the bid is to be of indicative nature only, selected applicant shall coordinate the construction works as per current state of the construction works with town of Uhersky Brod.

Query no. 4:

Some structures, ie. 23 18 01, 23 17 02 and other structures include costs related to waste disposal, we assume, the costs remained in the item budgets as unintended error and all the applicant will provide the costs individually as per particular landfill or the costs are defined by the contracting authority ?
