

## EXPLANATION OF THE COMPETITION TERMS AND CONDITIONS NO. 1

On 4 February 2019, Správa železniční dopravní cesty, státní organizace, with its registered office at Dlážděná 1003/7, Prague 1, Postcode 110 00, ID No.: 709 94 234 (the “**Contracting Authority**”) commenced a procurement procedure on the architectural design competition called “**Architectural Design of the Veleslavín railway station**” published in the Tenders Electronic Daily under registration no. Z2019-004321 (the “**Design Competition**”). The Design Competition has been announced as an open design competition pursuant to Section 145 of Act No. 134/2016 Sb., on Public Procurement, as amended (the “**PPA**”).

The Contracting Authority is hereby providing an explanation of the Competition Terms and Conditions pursuant to Section 98(3) of the PPA including the exact wording of the request without identification details of the prospective participants who has requested the explanation, and also provides an explanation on its own initiative, pursuant to Section 98(1) of the PPA.

On 4 February 2019 and on 5 February 2019, the Contracting Authority received written requests for explanation of the Competition Terms and Conditions pursuant to Section 98(2) of the PPA from two different prospective participants. The Contracting Authority provides the explanation of the Competition Terms and Conditions in both Czech and English languages.
