The Contracting authority would like to draw the attention of the parties potentially interested in participation in the Competition to the following facts.

During the submission of a request to participate / a confirmation of participation, or a competition proposal in the 1st and 2nd phase of the Competition, it is necessary to **choose the signature method** in the contractor environment and **enter the choice of electronic signature**.

Depending on the browser used, there are two possible signature methods and choices of an electronic signature. None of these procedures makes it necessary to have an electronic signature.

PROCEDURE I.

In some cases (browser types) it is necessary to follow the individual steps described in Annex P28 of the Competition Conditions - Safe Submission Guide for the "Method of Signature" ("**Metoda podpisu**") window and mark the option "Send without signature" ("**Odeslat bez podepsání**") and select the "Continue" ("**Pokračovat**") button.



In the next step, the participant selects the "Send without signature" ("**Odeslat bez podepsání**") button.



PROCEDURE II.

In other cases (browser types), the following steps must be taken when submitting the request to participate / the confirmation of participation, or the competition proposal in the 1st and 2nd phase of the Competition:

In the "Method of Signature" ("**Metoda podpisu**") section, select the method "Sign using a browser (does not require Java)" ["**Podepsat s použitím prohlížeče (nevyžaduje Javu)**"] and select the "Continue" ("**Pokračovat**") button.
