

EXPLANATION OF THE COMPETITION TERMS AND CONDITIONS NO. 15

Správa železnic, státní organizace, with its registered office at Dlážděná 1003/7, Prague 1, Postcode 110 00, Czech Republic, ID No.: 709 94 234 (the "Contracting Authority"), commenced a procurement procedure regarding the design competition entitled "Správa železnic Headquarters", published in the Tenders Electronic Journal under registration no. Z2020-034118 (the "Competition"). The Competition has been announced as an open design competition pursuant to Section 145 of Act No. 134/2016 Sb., on Public Procurement, as amended (the "PPA").

The Contracting Authority has received a written request for explanation of the Competition Terms and Conditions pursuant to Section 144(2) of the PPA from a prospective participant interested in participating in the Competition. The Contracting Authority hereby provides an explanation of the Competition Terms and Conditions in both Czech and English languages including the exact wording of the request for explanation of the Competition Terms and Conditions, without identification details of the prospective participant who has requested the explanation.

	Request of the participant where the explanation was provided based on a request for explanation	Explanation of the Contracting Authority
1.	Original request: Should we preserve the statue which is currently located on top of the terminal? Is there a historical meaning to the statue? Is the black cylinder in the model placed to represent this statue?	The question does not clearly specify the part concerned. If it means the structure in front of the Terminal, it is outside the competition area and is not subject of the competition entry. If it means the structure above the additional entrance chamber, it is a schematic solution that will be subject of the finalisation of the competition entry with regard to the design of the entrance to the chamber.
2.	Original request: Regarding the ramp, may you please provide additional information about the carrier system?	The coordination of the administrative building and the ramp construction systems will be subject of the finalisation of the competition entry. The competition entry should principally enable such coordination.
3.	Original request: When we analysed the competition brief and the P06 file provided we have noticed that a part of the C building is included in the terminal project too. There are retail units on the plans of the terminal which crosses the C building of the competition area boundaries. Should we design assuming that the whole competition area is empty or should we	The question does not clearly specify the part concerned. The Terminal and the Building C are two separate buildings interconnected only on the first underground floor. The competition area does not interfere with the Terminal building. The Contracting Authority does not expect designs of retail units in the Terminal.



	preserve the retail units of the terminal which crosses the competition area boundaries.	
4.	Translation of the request: According to the latest update, the table of empty areas such as "office premises – meeting rooms and hubs" will also include catering businesses, pre-school groups and other utility areas. Should this category also include the retail area?	Yes, it also includes the retail area.

For the avoidance of any doubts, the Contracting Authority states that the provision of explanations above does not constitute a change in the Competition Terms and Conditions within the meaning of Sections 98(5) and 99 of the Public Procurement Act.

The Contracting Authority reminds that the current time limit for submitting competition entries has been set until 12 February 2021, 5:00 p.m. CET (Central European Time).
