

## **EXPLANATION OF THE COMPETITION TERMS AND CONDITIONS NO. 16**

Správa železnic, státní organizace, with its registered office at Dlážděná 1003/7, Prague 1, Postcode 110 00, Czech Republic, ID No.: 709 94 234 (the "**Contracting Authority**"), commenced a procurement procedure regarding the design competition entitled "**Správa železnic Headquarters**", published in the Tenders Electronic Journal under registration no. Z2020-034118 (the "**Competition**"). The Competition has been announced as an open design competition pursuant to Section 145 of Act No. 134/2016 Sb., on Public Procurement, as amended (the "**PPA**").

The Contracting Authority has received a written request for explanation of the Competition Terms and Conditions pursuant to Section 144(2) of the PPA from a prospective participant interested in participating in the Competition. The Contracting Authority hereby provides an explanation of the Competition Terms and Conditions in both Czech and English languages including the exact wording of the request for explanation of the Competition Terms and Conditions, without identification details of the prospective participant who has requested the explanation.

1.	Translation of the request: How should part <i>d</i> ) Technical reports – anticipated energy performance of the building be prepared? Should it merely be a basic design of the technical installations in the buildings (heating, ventilation, air-conditioning, electric installations, etc.) and a specification of the anticipated energy efficiency class, or do you require us to calculate the anticipated consumption per individual sources (total consumption of electric energy, water, gas, etc.)?	A general design, a description of technical equipment incl. a plan of its location (large technological equipment / machine rooms) in the building (underground premises or roof) and the determination of the expected energy performance class are expected.
2.	Original request: We read in P01. Competition Brief that 'The Contracting Authority prefers the General Directorate(GD) to be housed in a separate building that may be linked to the remaining buildings (e.g. through subtle structures). The remaining buildings are to house the Construction Administration - West (CAW), Centre for Telematics & Diagnostics (CTD), Railway Geodesy Centre (RGC), Shared Services Centre (SSC), and the Fire & Rescue Service (FRS).' What are the remaining buildings? Does it refer to the terminal station? Are the	More details are set out in PO2_BUILDING PROGRAM_EN. The position of the General Directorate and the organisational units in buildings "A, B, C" is not strictly prescribed, nor is the number of the designed buildings. The specified area of building "A" does not have to be built up. No building programme for the Správa železnic Headquarters will be placed in the Terminal building.
