On 31 May 2021, i.e. after the deadline set in paragraph 9.4.1(c) of the Competition Conditions, the Contracting Authority received a request for an explanation of the Competition Conditions. The Contracting Authority decided to provide an explanation based on this request, in accordance with Section 144(2) of Act No 134/2016, on public procurement, as amended, using paragraphs 9.4.2. and 9.4.3. of the Competition Conditions.

**Inquiry No 138:**

Is it possible to provide recent photographs of the physical model of surroundings? Have the same colours been used for final treatment, which were recommended for the insertion model? What type of tree staffing has been or will be used for the model (material, colour)?

**Answer:**

Current photographs, which show the colour and staffing of trees, are provided in Annex 1 to this Explanation and also in the Explanation of the Competition Conditions No 27. The model uses the colours recommended in Annex 2 to the Call for Submission of Proposals in the 2nd phase of the Competition.

**Inquiry No 139:**

The supporting 3D digital model for the insertion model was updated for the second phase of the competition. The new supporting material (Annex 4 to the Call – Specification of P14) is missing the representation of the water level in the river for example. Has the 3D digital model for the model of the surroundings been changed accordingly or otherwise updated too? If so, could the updated model be provided to the participants too, so the insertion model would fit correctly?

**Answer:**

The new supporting document contained in Annex 4 to the Call for Submission of Proposals to the 2nd phase of the Competition – Specification P14 was provided directly by the model manufacturer and corresponds to changes in the model of the surrounding area. The manufacturer has not made any further changes to the insertion model and the insertion model should correctly connect with the model of the surrounding area.
