On 6 - 7 December, 2022, a meeting of the Evaluation Committee was held to assess/evaluate the **Concepts** submitted to the Procurement Procedure for the award of the Public Contract entitled "**Nový hlavák (New Main Station District)**", whose co-contracting authorities are the Capital City of Prague represented by the Department of Property Management of the Capital City of Prague, the Prague Public Transit Company, a joint stock company and Správa železnic, state organisation. The co-contracting authorities are represented externally by Správa železnic, state organisation (the "**Contracting Authority**").

The minutes of the Evaluation Committee meeting were taken and handed over to the Contracting Authority on 21 December 2022 (the "**Minutes**"). Based on the opinion of the Evaluation Committee expressed in the Minutes, the Contracting Authority, in accordance with Section 69(4) and (5) of Act No. 134/2016 Sb., on Public Procurement, as amended

- **decide and notify the exclusion to the parties concerned; and**
- **issues a Call for the submission of the Draft Design to the parties concerned.**
